What is the purpose of processing my Personal Data?

We also hold personal data on our staff, volunteers, members of Friends of Glenariffe and anyone registering for Gift Aid for our fundraising activities. All personal data held will be:

- Processed fairly and lawfully
- Collected for specified, explicit and legitimate purposes
- Adequate, relevant and limited to what is necessary
- Accurate and where necessary kept up to date
- Kept for no longer than is necessary
- Processed in a manner that ensures appropriate security

Who will have access to my Personal Data?

As an external, third party Data Processor, we also have contracts in place with a small number of banking and online booking agents who manage our finance and booking systems and with whom we have agreements in place to ensure that your Personal Data is stored safely and securely.

How long will your Personal Data be stored for?

Your Personal Data will be held for the duration of your engagement with Glenariffe Community & Recreation Centre classes, activities and programmes, your Gym 208 membership or your financial support to the Friends of Glenariffe and will be deleted from our systems when you terminate any of those aforementioned engagements with us.

What are my privacy rights relating to my Personal Data?
